Did your family earn less than \$37,000 in 2005?


If so, you may qualify for the Earned Income Tax Credit (EITC)



Two or More Children	\$37,263	\$4,400

What to bring to get your taxes done:

- All W-2s and 1099s (if any)
- Picture I.D.
- Social Security Cards for all family members
- (or Individual Taxpayer Identification Number Cards)
- Voided bank check for direct deposit
- Copy of 2004 tax return (if available)
- Childcare provider information & tax ID # (if any)
